This is to inform to all the institute Head of Pharmacy that, as per instruction of competent authority of GTU, the scrutiny committee has scrutinized all the cases of title change (Total 666 cases) done after ITD examination but before Mid sem examination. Out of all these cases, in 15 cases students have entirely changed their project after ITD exam. As entire project work has been changed by such students, the rational of ITD work has been compromised.
