- 2. I know that <u>GTU</u> will not be responsible if I do not carry/purchase foreign exchange as per the rules of Reserve Bank of India. I am advised to buy all the foreign exchange from authorized money-changer and it should be endorsed in my passport with proper receipt.
- 3. I understand that **GTU** will not be responsible for any injury, sickness, accident, death, loss of baggage, loss of cash, loss of any electronic gadgets etc. or any other mishap taking place during the entire journey from <u>the end of May 2011 to the end of July 2011</u>.
