- 2) Name of programs run by the College/ Institute/ Technical Campus. Full time/ Part Time (Diploma Engg./ Degree Engg./ Diploma Pharmacy/ Degree Pharmacy/ MBA/ MCA/ any other)
- 3) Whether the Post of regular Director/ Principal is Filled as per AICTE/ GTU/ Gujarat Govt. norms: YES/ NO. if yes then give following details:-
 - a) Full Name,
 - b) Age
 - c) Date of birth
 - d) Academic Qualification and Experience* (at the time of advertisement) as per the AICTE/ GTU/ Gujarat Govt. norms
 - e) Date of appointment *
 - f) Date of joining*
 - g) Total experience in year and month (as on today as a Principal/ Director)
 - h) Whether the age of the Principal/ Director is above 65 years as on today? YES/ NO. (e.g. (A) A teacher in Physics/ Mathematics/ English/ Chemistry subject is not qualified as a Principal/ Director in Engg. College.
