
No:GH/SH/53/2011/PVS/102011/1313/S:-In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Business Administration Courses (Regulation of Admission and Payment of Fees) Rules, 2008, namely:-

1. (1) These rules may be called the Master of Business Administration Course (Regulation of Admission and Payment of Fees) (First Amendment) Rules, 2011.

2. In the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2008, rule 17 shall be numbered as sub-rule (1) of that rule and after sub-rule (1) as so renumbered, the following sub-rule shall be added, namely:-

“(2) Notwithstanding anything contained in these rules, for admission in the academic year 2011-12, a candidate who is otherwise eligible under these rules but has not appeared at GCET examination shall also be eligible for admission to the first year Master of Business Administration Course, on the seats declared vacant under sub-rule (1) of rule 17.”.
