Section 46 ("Non-discrimination in the built environment") of the **Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 ("the PwD Act")** casts an obligation on the appropriate governments to, *inter alia*, provide certain facilities and services in public buildings to persons with disabilities (PwDs). Article 9 ('Accessibility') of the **UN Convention on the Rights of Persons with Disabilities (UNCRPD)**, which is relevant to all Ministries, also says that PwDs should have access, on an equal basis with others, to the physical environment, to transportation, to information and communication, including information and communication technologies and systems, etc.

2. Soon after coming into force of the UNCRPD, the then Minister, SJ&E, had drawn the attention of your Minister, vide her D.O. letter no 13-01/2007/DD-III dated 19.5.2008, to the provisions of the said Article 9, as also to other provisions of the Convention relevant to your Ministry. Again, in January this year, the present Minister, SJ&E, had, vide his D.O. letter dated 30th January, 2010 (copy enclosed as **Annexure-I**) written to your Minister requesting to make public buildings and websites of various Departments and Organizations under your Ministry accessible to persons with disabilities.

3. This Ministry has been providing financial assistance for undertaking activities in pursuance of the PwD Act, under a Scheme known as the "Scheme for Implementation of Persons with Disabilities Act, 1995 (SIPDA)".

In the context of para 2 above, it has been decided to provide non-recurring grants to institutions/organizations under the Central and State Governments under SIPDA, in the current financial year, especially for the following two purposes:

- i) To provide barrier-free environment in important government buildings, which would include provision of ramps, rails, lifts, adaptation of toilets for wheelchair users, brail signages and auditory signals, tactile flooring, etc.

- ii) To make websites accessible to PwDs, as per guidelines for Indian Government Websites issued by the Department of Administrative Reforms and Public Grievances (D/o AR&PG), Government of India, which are available on their website <http://darpg.nic.in>.

4. Indicative cost ceiling for the above two types of activities, which could be supported under SIPDA, are:-

- i) For making buildings barrier-free - upto Rs. 50.00 lakh per building
ii) For making websites accessible - upto Rs. 20.00 lakh per website

Preliminary cost estimate of the proposed work, in respect of each building/website, would have to be worked out by the concerned organization/institution, broadly within the indicative ceiling.


5. As regards your Ministry, we would be happy to sanction grant under SIPDA for the above two purposes, to the following:

- (i) UGC
(ii) Central Universities
(iii) Other autonomous bodies and institutes^{ions} of the Department.

6. I would be grateful if you could please urgently advise the above mentioned organizations to send self-contained proposals for financial assistance under SIPDA, for undertaking activities mentioned in para 4 above, in the proforma enclosed at **Annexure-II**, so as to reach the Joint Secretary (Disability) in this Ministry **latest by 15th January, 2011**.

7. I would appreciate an early line in reply.
