## PG DIPLOMA IN FINANCIAL MARKETS ENTREPRENEURSHIP

GTU has decided to launch a specialized one-year part-time Post Graduate Diploma in Financial Markets Entrepreneurship Course in collaboration with National Stock Exchange of India Ltd. (NSE), which aims at preparing entrepreneurs for trading in different financial markets segments ó on their own or with market participants. It is a comprehensive course on all major financial markets that is especially designed to equip an individual with the desired knowledge, tools and skill sets to become entrepreneurs in a large and growing field.

### **Major Objectives:**

- 2. To provide hands-on exposure to practice in financial markets ó cash and derivatives segments.
- 3. To give the opportunity to work in a financial technology lab with a simulated trading environment using live market data.
- 4. To create financial entrepreneurs and knowledgeable traders in sophisticated financial products ready with the required financial market skills.
- 5. To inspire students to start and run their own entrepreneurial venture for financial markets investors or market participants.

#### **Entry level qualifications for admissions:**

Two-year Masters of Business Administration (MBA) from any recognized university from India/Abroad - <u>OR</u> - Post Graduate Courses (in Commerce, Management & Economics) from recognized university in India/Abroad including PGDM approved by AICTE/AIU - <u>OR</u> - Bachelor Degree from recognized university with minimum 3 years of full time work experience in Financial Sector - <u>OR</u> - CA/CS/ICWA.

**Course Fees:** Rs. 60,000/-

**Admission Procedure:** The admissions will be given on the basis of merit. Reservation norms as per the Government of Gujarat. The detail of eligibility and their weightage under each qualification is as under:

Eligibility Criteria	% of weightage
(1) MBA with any specialization from recognized university.	70%
(2) Other PG Courses (in Commerce, Management & Economics) from recognized university in India / abroad including PGDM approved by AICTE/AIU.	10%
(3) Bachelor degree from recognized university with minimum 3 years of full time work experience in a Financial Sector (with a registered firm / institution).	10%
(4) CA / CS / ICWA	10%
Total	100%

Note: If the numbers of suitable applicants in any category are not sufficient, the seats will be transferred to the MBA category. If the applicants in the MBA category are less, the seats will be transferred to other categories in equal proportion.
