Moreover, in semester IV the students have been exempted from studying the subject: Dispensing Pharmacy II & Pharma Industrial Management (2240002) (Theory and Practical), and Basic Concepts of Pharmacology and Clinical Pharmacy Practice (2240005) (Theory) whereas they have to study the subjects Pharmaceutical Analysis II (2220003) (Theory and Practical), Physical Pharmacy (2220001) (Theory & Practical) and Basic of Computer Application – II (2220005) (Practical) in semester IV.
