- 2) All other M.Pharm (Sem- III & IV) Students (except listed under annexure-3) are Qualified in their respective component of remedial (ITD/Mid Sem/Final Dissertation), they can appear in their next component of exam (if applicable) during 1<sup>st</sup> Phase of Final Dissertation as schedule mentioned on GTU Website.
