It is a program of the Indian Institute of Technology Delhi, with logistic support from the Foundation for Innovation and Technology Transfer (FITT). The Program runs throughout the year in four batches of different durations (Jan-May/May-July/July-Dec/Dec-Jan).

Applications are invited from Students who are registered in a recognized Engineering Institute / College / deemed University in an Engineering Discipline in the Electrical Sciences (Electrical Engg, Computer Science, Electronics, Communication/Telecommunication, Instrumentation and allied Electrical Sciences). For professionally qualified Engineers, it offers Returnships and Gap Internships. Women engineers and meritorious engineering students who need support or have special needs to fulfill professional aspirations are encouraged to apply under its affirmative action initiative.

The GIPEDI Internship is designed *differently* - it does not just train students to execute projects, it trains them in project planning, requirements analysis, specification generation, design iteration management, team work and ethics, behaviour management, team building, group etiquette and communication skills. Apart from a full set of technology modules, it also uses specially designed training modules in ethics, history through heritage sensitization / heritage walks and lessons from mythology to teach culturally-conscious and effective engineering practices.
