Guidelines:

- 2) Students **review comments** (<u>Old Review Cards</u>) must be submitted to Expert Panel at the beginning of review.

Students should present:

- a) Hall Tickets issued by the University
- b) Concise Literature Review
- c) Justification for their topic
- d) Objective and rationale
- e) Work done; Results; conclusions
- f) Student must carry review <u>cards of ITD winter 14 exam and mid review</u> <u>exam RW 2015</u> and Final Dissertation Phase I (In case of remedial student only) comprising comments of the experts
- g) Compliance to comments

Instructions:

- Presentation duration per student: 20 min + 10 min Interaction.
- Students are required to bring presentation preferably on CD rather than pen drive.
- Student should carry **3 Hard copy** of the thesis. (For endorsement by examiners and all 03 copies will be returned to students in the evening)
- Review Exam will start sharp at 10:00 am
