In India today most of the buildings extensively use Glazing in form of Facade Glazing or in the form of large windows. The installation and Glass processing have emerged as one of the important areas of employment in Gujarat. Gujarat is facing acute shortage of Skill required for glass façade fabrication and installation Technology.

In order to develop need based skilled manpower in the emerging sector (glass façade, fenestration and glass processing industry), the Glass Academy joined hands with Gujarat Technological University to impart glass façade & processing skills and such other skills to the Diploma/ Degree students of Civil & Mechanical Engineering in the GTU premises. GTU is the only University in India to commence the program in Glass Processing Technology.
