#### **NOTIFICATION**

The Recruitment Rules were placed before the BOG in its meeting held on 5th August 2011 vide Agenda item 7, to these, the BOG authorized the University to fill the posts after following due procedure of UGC / Govt. of Gujarat including reservation policy. The Recruitment Rules in which there were some discrepancies, the same were corrected and framed the fresh Recruitment Rules. The advertisement for filling the non-teaching posts were published with the newly framed Recruitment Rules. The said Rules were circulated by the undersigned in October - 2012.

The BOG has approved the newly framed Recruitment Rules in its meeting held on 2nd January, 2012 Vide Agenda Item No. 4.

As the undersigned is empowered to fill up the non-teaching posts Vide Resolution referred to above at Sr. No. (1), it was necessary to have a Selection Committee for these non-teaching posts including the post of Registrar. As per advertisement, the applications received for the various posts have been scrutinized and it is highly necessary to constitute Selection Committees for various posts, till the Regulations are framed / approved by the BOG.

Now in view of above and for the implementation of Resolution referred to above at Serial No. (1), the undersigned, in exercise of powers vested under Section - 12(4) of the GTU Act 2007, constitutes the Selection Committee of various post as under.

- (1) Selection Committee for the post of Registrar.
  - (i) the Vice-Chancellor or his nominee as Chairman
  - (ii) One Vice-Chancellor/ ex-Vice-Chancellor of some other Universities nominated by the Vice-Chancellor.
  - (iii) one member of the BOG nominated by the Vice-Chancellor

- (iv) two experts, nominated by the Vice-Chancellor
- (2) Selection Committee for the posts of Grade- I & II i.e. the posts having Grade Pay of Rs. 4600 and above.
  - (i) the Vice-Chancellor or his nominee as Chairman.
  - (ii) two or three experts to be nominated by the Vice- Chancellor the experts may be existing or present Vice-Chancellor, Registrar, Dean, CAO, Chief of Computer Services or any other suitable persons
  - (iii) one member of the BOG nominated by the Vice-Chancellor
  - (iv) the Registrar of the University.
- (3) Selection Committee for the post of Grade III i.e. the posts having Grade Pay less than 4600.
  - (i) the Vice-Chancellor or his nominee as Chairman
  - (ii) two or three experts to be nominated by the Vice- Chancellor the experts may be existing or present Vice-Chancellor, Registrar, Dean, CAO, Chief of Computer Services or any other suitable persons
  - (iii) one member of the BOG nominated by the Vice-Chancellor
  - (iv) the Registrar of the University.

The Selection process of the following posts shall be completed as soon as possible.
