Subject Name : Industrial Project and Training

Point No.	Details
01	The Industrial Project and Training is an essential component of the curriculum of Diploma in Textile Processing Technology Programme. It is highly required for a student to familiarize with Industrial environment and current & latest working methodology of various wet processes in the industry.
02	Total 16 weeks (08hrs/day) are to be allotted to each student for a complete training in various Departments and Laboratories of any Textile Processing Industries / Quality assurance Laboratories / Textile Research Institutes with the prior permission of these organizations.
03	During training, All the students have to remain in contact with the concern faculty members of his institute at faculty conveniency (During Office Working Hours). While undergoing training, he/she should collect all the necessary information of the machineries with drawing, methods, processes, variety of sample collection (if possible), record keeping techniques, various formats, data transfer techniques, preparation of plant-layout of each department and complete Industry. From these information, all the students have to prepare a computerized project report with spiral binding. The students have to maintain their daily diary/record book most regularly and have to show it whenever any faculty member demand to check it during his follow up round. Day to day presence reports with the signature of concern department's head should be submitted by the student to the deputed faculty member of textile processing department at his institute.
04	The behavior of the students undergoing training must be well polite and with discipline. They have to follow the rules and regulations of the industry. The decision taken by the management of the industry will always be the final decision.
05	At the end of training and before leaving the industry, student has to collect their Training Certificate from the Industry, which should be attached as a very first page in his project report. The project report indicating the details of complete training and work done in the industry should be submitted on the date declared by the textile processing department at his institute.
06	The students will be evaluated for their industrial project and training by one

	external examiner deputed by GTU and one internal examiner. All the students have to face the viva examination and defend his industrial project report.
07	<p>This Subject will carry total 150 marks as under:</p> <p>7.1 At the end of training, the students have to submit their Project Report on or before the date declared and displayed by the Textile Processing Department at their Institute.</p> <p>7.2 The regularity & punctuality in their attendance in the industry during their training period and the preparation & submission of their Project Report will carry 50 marks.</p> <p>7.3 The Students will be evaluated from their Quality of Project work & Project Report and Performance in Oral/Viva Examination by ONE External Examiner deputed by GTU and ONE Internal Examiner. The students have to appear in Oral/Viva examination carrying 100 marks which also includes overall performance of the student.</p>
