Important Circular Regarding Practical Work Evaluation

<u>The HoDs/Principal/Director/Head of Institutions of all affiliated Colleges of Bachelor of Engineering</u>

GTU has decided to reform the practical work evaluation (along with viva-voce) from the academic year 2016-17 onwards. It has been decided that the practical work (along with viva-voce) will be evaluated along with the current practice of viva for all the subjects in which there is credits of practical. The practical work evaluation (along with viva-voce) for all such subjects from **semester 1 to 4** will be taken by the respective college for its students. That is, there will be only internal evaluation (no external viva examination) for practical work evaluation (along with viva-voce) in semester 1 to 4. The practical work evaluation (along with viva-voce) for all such subjects from **semester 5 to 8** will be taken by external examiner.
